## All Puppy Clients:

Deposits will **NOT** be accepted until this form is signed and returned. Puppy selection order is based on date and time deposit is accepted.

- 1) The Breeder (Von Der Haus Gill German Shepherds) reserves first selection from **ALL** litters for either or both sexes. All deposits will be in order received after the breeder makes their selection. If the breeder chooses to not make a selection then all deposits will be moved forwards one (1) spot.
- 2) Deposits are accepted based on litter and sex only. Buyer is required to make selection on Sire/Dam first. Followed by puppy sex.
- 3) All deposits are **NON-REFUNDABLE for any reason**. If there are not enough puppies available then the buyer will have the following options.
  1. Buyer will have option to move deposit to next breeding for which they had made original deposit. Buyer will be after any current deposits on said litter. This means you are not guaranteed the same pick position.
  2. Buyer may choose to move to different male/female breeding after any current deposits on said breeding.
  3. Buyer may choose to move to opposite sex if there are any puppies available. Buyer will move to bottom of the selection list.
  4. Buyer may transfer puppy deposit to adult/young dog.
- 4) We can not guarantee puppy color, drive, or temperament. We can NOT guarantee any time frame for Buyer to receive a puppy. This means your puppy may be ready within a few weeks or in some unusual cases it could be many months even a year or more depending on which Sire/Dam you request. If you choose not to select a puppy based on these reasons your deposit and selection spot will be forfeited. There are no refunds simply because of wait time for the puppy.
- 5) All returned checks or cancelled credit card deposits are subject to \$50.00 service fee due 15 days after Breeder notifies the Buyer. Failure to pay service fee within 15 days of notification will result in the matter being turned over to Auglaize County Municipal Court. Any legal arising from this agreement, you acknowledge will only be filed in Auglaize County Ohio Municipal Court. You further waive any rights to file any claims in any other courts.
